SCRUTINEERING ADVISORY PANEL

Meeting dated 1st November (Excerpts of minutes)

99.101 Panel seeks urgent clarification with respect to Production Rally Cars, Rule 3.10(ii).

"Trimmings below the dashboard, and which are not part of it, may be removed.

It is permitted to remove the centre console so long as it does not hold any heating controls or instruments"

What constitutes a dashboard? Is it the same in the FAI Group A Rule 5.7.3.3 and Diagram 255.7? If so, can this rule be included in the PRC Rules in the 2000 Manual or clarified by way of a Technical Bulletin to avoid any further competitor and Officials confusion.

RALLY ADVISORY PANEL

Meeting dated 9th November (Excerpts of minutes)

SCRUTINEERING ADVISORY PANEL

Meeting dated 6th December (Excerpts of minutes)

99.104 Ref. SC2804 – Pre Log Book Inspections.

This matter has been discussed with State Council Chairman, QuMan and ScAP Chairman and resolved that this would be left to the discretion of the individual Scrutineer.

STATE OFFICIATING PANEL

Meeting dated 6th December (Excerpts of minutes)

- 99.053 Various aspects raised in S. Chopping's letter were discussed with clarification of the following points being requested.
 - Auto Issue of Grade 4 Licence.

Panel queries if the automatic issue of Level 4 Licences applies to Stewards at remote events (ie Nth Qld) it may well be difficult to ensure a Grade 3 (or higher) Steward can attend to act as the Senior Steward. Panel feels that all applications for Stewards Licences need to be reviewed in light of this possible inability to ensure supervision will be provided.

- Upgrade from 4-3.

Panel notes the relevant paragraphs of Mr. Choppings letter in applications for upgrading in Categories (specifically, Stewards, General Competition Area and Scrutineering) are required to complete Applications for recognised Prior Learning etc., or in the case of other categories to submit evidence to confirm criteria have been met.

Panel notes that while Mr. Chopping's letter is dated 28/10/99, a number of applications which have been assessed by this panel prior to this date have been returned as not meeting the criteria.

Panel notes that the authority to assess upgrades lies with the State panel and is of the opinion, that provided Panel is satisfied that criteria has been met, no further correspondence (other than issue of the relevant licence) is necessary.

Whilst Panel understands the intent of such verification, we feel that to make the matter retrospective, is creating unnecessary and frustrating aggravation to volunteer officials. Members of this Panel have been appointed by Qld State Council with regard to their knowledge of personnel and their experience and compliance, with a view to expedite licence issue of upgrades. If these aspects are to be paper based and handled by clerical staff we suggest that all State Officiating Panels be disbanded.

What is a hillclimb?

It's an event which pits you and your car against a challenging uphill course.

It's the art of driving a car on cold tyres as quickly and neatly as possible around the corners and up the hill, up a bitumen road sometimes no wider than a garden path.

Each run up the hill provides its own challenge to improve on your past times and beat the other cars in your class, or to aim for the fastest time of the day.

The event comprised of competition timed runs, allowing drivers to try their hardest to improve their times during the event. The winners are the ones with the fastest times for the event in each class, and the overall winner is the one with the fastest time on the day.

One of the most social motorsports, hillclimbing at all levels provides a friendly atmosphere for you to gather with cocompetitors and spectators, to watch and assist each other while providing an exciting competition.

What can I drive?

Hillclimbers run virtually anything from their everyday road car through to purpose built 500 horsepower open wheeler 'specials'.

Your chose of vehicle will determine the class in which you compete.

Competitors often change their cars and classes as they become more involved and more competitive in hillclimbing.

What do I need?

If your starting out, your road car is fine, as long as you meet CAMS basic safety requirements, including a seat belt, a fire extinguisher and an AS 1698 helmet.

You will also need flame resistant clothing (not necessarily a race suit) that protects you from your neck to your ankles and wrists. And of course, you'll need a CAMS licence.
