#### **Motor Race Advisory Panel**

Meeting held 3<sup>rd</sup> August 2000 (excerpts from minutes)

- 00.076 Fire Extinguisher Brackets
  Oran Park incident highlighted problem with having 'fire bomb' in habiticle
- 00.078 Panel was advised of an incident at Queensland Raceway where a competitor was found to have a metal stud on her tongue. Panel believes this presents a risk of tearing and haemorrhaging, which could lead to choking in the event of an accident, suggests this be referred to National Office for consideration.

#### **Scrutineering Advisory Panel**

Meeting held 7th August 2000 (excerpts from minutes)

O0.040 Rally Car Regulations – Ref. PRC Regulations
CAMS Manual page 11-57 sec3.10 Cockpit.
Paragraph (ii) and (vi) appear to contradict each other and have caused some problems with interpretation at events in Qld. Ref correspondence from Ferris Lee to CAMS and case raised by Chief Scrutineer Dave Woods at Rally Queensland 2000. Panel requests clarification from Australian Rally Commission or Technical Committee.

00.043 Body Piercing

The Panel seeks to advise the CAMS Medical Assessment Panel of the growing trend by competitors of body piercing ie; tongues, eyebrows, noses, ears, etc. These items may, in accident situation, cause problems for

competitors, and feels that some guidelines should be available from the CMAP.

00.045 Battery Boxes

It has been noted that in some competing cars, where the battery box is situated in the driving compartment, the locating bolts (retainers) are too weak to retain the battery in an accident, with the battery becoming detached and moving in the compartment, with risk to driver. Panel seeks a minimum specification for both mounting bolts and retention straps secured by bolts with mounting plated into body panels be mandatory for the battery, and for any other cockpit items, ie. fire extinguishers.

#### **State Officiating Panel**

Meeting held 7th August 2000 (excerpts from minutes)

00.023 Panel reviewed procedure for Licence Renewals where applicants are required to forward Renewal Forms to Melbourne, from where they sent back to State Offices for processing, then returned to Melbourne for Licence issue.

Panel believes that this is not cost effective, is time consuming and involves unnecessary double handling. Currently Queensland State Officiating Panel is adequately represented across the disciplines, and if Panel meets every month, the paper flow will not be a problem. Panel believes current forms are not adequate in that there is not provision for endorsement by a club to verify CAMS Membership.

# 2000 CAMS MANUAL OF MOTOR SPORT APPENDIX R.

#### REFERENCE:

2000 CAMS Manual of Motor Sport, Section 15, Appendix R, FINES AND APPEALS, p15-13

#### RATIONALE:

To remove the reference to GST payable on fines.

#### **AUTHORITY:**

The new tax system as introduced by the federal government on July 1, 2000 does not incorporate a GST on fines.

#### **ACTION:**

Amend Appendix R, Fines and Appeals, as follows:

"FINES AND APPEALS \$ A \$B FINES (maximum permissible)

By CAMS or AMSAC 250,000 275,000 By a CAMS Tribunal 250,000 275,000

By State Council or Stewards of a Meeting 15,000 46,500

By AMSAC for misbehaviour in a court session 5,000 5,500

By Chief Executive or State Secretary

(Being an administrative penalty [see NCR 185(v) (b)] - up to 50% of permit fee minimum.

Min. of **50** 

50

Failure to produce Licence/s

(Payable only if permitted by stewards to compete)

54

Failure to produce Log Book

(Non-production results in exclusion from competition) 50 55"

Please note that the remainder of the section on Fines and appeals specifically relating to Protest Fees and Appeal fees remains unchanged from that printed in the 2000 Manual of Motor Sport.

# (another!) SHELL HELIX RALLY TEAM STORY

#### Railway Hotel Forest Rally 2000

September 23<sup>rd</sup> saw three Townsville crews travelling to Yeppoon for the Railway Hotel Forest Rally 2000 organised by Gordon Fisher from the Central QLD Motor Sporting Club. The event ran smoothly thanks to the effort put in by Gordon and his band of helpers.

The rally started at the Railway Hotel in Yeppoon on Saturday at noon. The forest roads were dusty and quite demanding and unfortunately during the second section Graham and Kate Telford from the Tonka-Tec crew panel beat the side of their car with a tree and shortly after did the gearbox. With only 1<sup>st</sup>, 3<sup>rd</sup> and 5<sup>th</sup> gears left they were forced to retire.

Townsville's Shane and Juanita Ogilive also encountered a number of problems along the way including hitting a tree, brake trouble, slipping clutch, flat tyre. Even after these mishaps Shane and Juanita finished 2<sup>nd</sup> in the 4WD class and 6<sup>th</sup> place overall- CONGRATULATIONS!

In an unbelievable coincidence both the KC Rally Sport cars suffered failed terra-trips after SS7. Understandably KC, the front runner, became lost in the next section, putting us as the lead vehicle- with no skid marks to follow and only the second rally for the new navigator-what a challenge!

But luck seemed to be with us this rally. After replacing the oil cap at the end of SS2 (who forgot to tighten it (????) we looked to settle into a close competition. At the end of SS6 we noticed the bonnet a little bent up. Further inspection showed the strut tower coming away, held on by only two welds and the bonnet. With only a 15 minute service stop, there was no time to repair it so we promised to 'take it easy' and 'nurse it home' for the service crew to

fix in the next break. A quick change of a flat tyre and we were off.

No one expected to see us rock in after another 4 SS. The bonnet was a little worse for wear but we limped into the 1 1/2-hour service break. Since a welder was unavailable we used a bit of bush mechanics and lots of imagination to fix the problem. With a bit of chain, a spanner, bolts, cable ties and wire we secured the strut. Other minor problems included a broken muffler, broken upper control arm and leaking shocks. After again promising to 'take it easy' and 'nurse the car home' through the last three night sections, we were off again.

It was a distinct advantage being at the front of the pack for the night sections as the dust hung around for quite a while, making fast times difficult for the following cars. Unbelievably the strut tower held together and with a great sigh of relief we finished. After such a long and close rally we were caught totally off guard when they announced the overall results: 3rd-KC Rally Sport team; 2<sup>nd</sup>- Gary Meehan and 1<sup>st</sup>-McCubben/Nicolosi, including 1<sup>st</sup> in Clubman A.

A special thanks to the great bush mechanics and service crew from the Whitsunday's club. Also a big thanks to the sponsors of the Shell Helix team: Shell, Bill Dingle Crash Repairs, Top Gear Performance, Brennan's Tyre Service, Richard Kelly Automotive and Allan Shand & Co. We now have the challenge of getting the car in top running condition for the next rally.




