

## Sobering Issue For Club Sport

There are many aspects of a motor sport event which can be potentially hazardous to the general public and spectators, if not planned and managed correctly.

With sporting events increasingly being considered a 'workplace', organisers need to be aware of the health and safety implications of staging a motor sport event, especially when addressing areas that are not directly within the immediate competition area. Organisers must also take precautions to ensure that steps are taken to minimise health and safety risks participants and spectators.

It is very important for event organisers to consult with all persons and external organisations associated with the planning and operation of the event, which may include local council, property owners, emergency services, community or private services.

A Queensland rugby sporting club was recently fined \$50,000 for a breach under the Workplace Health and Safety Act resulting from the death of a toddler from drowning after falling into an open septic tank which was on the property under control by the club.

This highlights the need for event organisers and venues managers to be vigilant on areas that are under their direct control. There are many day-to-day activities in which a club is involved which could lead to injuries in breach of the obligations under the Workplace Health and Safety Act.

Whilst it is understood that some motor sport events may not be considered by civil authorities as a 'workplace', CAMS encourages all organisers of volunteer-based, amateur motor sport to participate in risk management procedures which will assist in providing a duty of care in the spirit of the Health and Safety Act's within each state.

The process of applying risk management procedures will ensure that such a duty of care is being understood and applied. This is done by identifying situations which have the potential to cause harm to people or property and then doing something to minimise the risk and hopefully avoid the hazardous situation occurring or the person being harmed.

The CAMS Risk Management Project is about developing and maintaining systems to enable a "safe event for all" through the use of the risk management system which aligns with the Australian Standard (AS/NZ 4360:2004). ## **RALLY AUSTRALIA**

Following a request received by i-METT Queensland Group Pty Ltd, the promoters of the Australian round of the FIA World Rally Championship (WRC), CAMS has submitted a formal request to the FIA seeking a postponement of the first Queensland event until 2009.

In October 2006, CAMS reached agreement in principle with i-METT to promote and organise Australia's WRC round and a five year agreement (with two five year options) was subsequently signed by both CAMS and i-METT in March of this year.

Since that time, CAMS officials have been developing the sporting aspects of the event. A highly skilled and experienced team comprising senior rally personnel from Queensland and the former Rally Australia team in Western Australia has made significant progress in preparation for a September 2008 event.

In addition to promoting the WRC round, i-METT also proposes to develop a large tourism precinct in South East Queensland, comprising an international standard motor racing circuit, theme park, hotels, automotive technology park and education facilities.

As part of its due diligence process, CAMS required, and was provided with, proof of i-METT's funding for the overall project, estimated to cost in the vicinity of \$650 million (Australian dollars).

The World Rally Championship project is closely linked to the construction and completion of the overall i-METT project, which in turn is dependent upon various Government approvals that are being progressed but have not yet been granted.

Whilst the receipt of this request is extremely disappointing to CAMS, having regard for the timing imperatives, CAMS believes that the request by i-METT to postpone the first Queensland event until 2009 is in the best interests of the FIA World Rally Championship, Australia's standing in the eyes of the world's motor sport community and the long term future of rallying in Australia.

"CAMS will continue to work with all parties to retain Australia's place in the FIA World Rally Championship calendar and to support the development of a world class motor sport precinct," said CAMS President Colin Osborne.

## Nissan Datsun Nationals 2009 (NDN09)

The Nissan Datsun Nationals is a biannual event drawing together motoring enthusiasts from around Australia. The inaugural event was hosted be the Z Car Club Q in 1991. The hosting has rotated between NSW, Vic and QLD every second year since then. To make this the biggest and best Nissan Datsun nationals we hope to attract a broad range of Nissan Datsun owners. We hope that some of your members may be interested in the event. To this end we are inviting your members to be involved in the event from the grass roots.

In 2009 the event will be held over the Easter long weekend at Warwick with the motorsport component to be held at near by Morgan Park. Our club will be planning the usual components for the event including a dinner, concours and sprint event. In addition to those we are considering ways to add something a little different. For example a state based competition where the best competitors from each state face off.

It might sound a long way off but we are hoping to have more than 250 entries from all around Australia so there are a lot of facilities and logistics to arrange.

Please contact me if you or your members are interested in playing a part in this event. We are looking for people to be motorsport competitors, concours entrants, social entrants, sponsors, officials, spectators and volunteers. #### **Excerpts of Minutes** QUEENSLAND STATE COUNCIL

Meeting held on Tuesday, 16th October 2007

Resolved that this State Council notes the SC Chairman's advice that the matter is being addressed by the State 5269 Ref. RAP07. 170 Qld Transport Update Council Executive.

5273 Graham Fountain - CEO of CAMS

Paul Overell, State Council Chairman, welcomed Graham Fountain, recently appointed as the new Chief Executive Officer of the Confederation of Australian Motor Sport; Graham Fountain commenced his new position on the 18th of June 2007. In introducing Graham Fountain, Paul Overell related that Graham came to CAMS following many years of service with Victoria's Country Fire Authority (CFA) in a diverse range of senior operation and management positions including his most recent role as Deputy Chief Officer where he was responsible for managing the Emergency Management portfolio. Paul Overell then extended an invitation to Graham Fountain to address the State Council delegates.

Graham Fountain briefed delegates on issues of both state and national importance including that the CAMS Board, Management, and a range of Staff and State, Commission/Committee representatives, recently participated in a two day offsite workshop, the aim of which was to take time out to set the strategy and direction for CAMS over the next five years. The team listened to the results from a substantial body of research into how stakeholders and members see CAMS.

From this information, which highlighted some crucial areas for improvement, the team made some powerful decisions which included:

The critical evaluation and restructuring of the leadership within CAMS – starting at the Board level and working downwards

A renewed focus for CAMS which moved beyond regulation and extended to representing motor

A redefined role for CAMS which will now more explicitly include being a facilitator for a wide array of avenues of motor sport and also motor enthusiasts

A clear strategy of shifting and improving the brand of CAMS and communication within both the motoring and the wider community in general.

Graham Fountain stated that the outcomes clearly demonstrate that CAMS has listened and is willing to act to rectify the identified deficiencies and deliver a new revitalised product and service to its members and the community Graham Fountain advised delegates that the first initiative being undertaken involves the centralisation of Event Permits and Vehicle Log Book administration to CAMS' Melbourne office saying that this work precedes the pending development of an online event permitting system as part of the new CAMS IT (Information Technology) Strategy and follows extensive consideration and analysis.

"CAMS recognises that this is a significant task and acknowledges that modifications, refinements and improvements will need to be made along the way as we progressively strive to achieve a best practice model. This is a clear demonstration that CAMS is listening to its stakeholders and striving to improve the way it does business, consistent with its new strategic direction", said Graham.

Additionally, in recognising a number of challenges facing CAMS and its new strategic direction, the Board and Management have announced an organisational review to examine the existing governance, organisational structure and consultative processes of CAMS. The review will involve extensive consultation with CAMS stakeholders (internal and external) and will recommend a structure, governance and consultative framework from which future strategies of CAMS can be optimised. A Board Steering Committee consisting of the President, two Vice Presidents and CEO will oversee the review and have recently appointed Ernst & Young as independent consultants to undertake the review.

A question and answer period followed Graham Fountain's address during which time delegates were spirited and vigorous with their questioning and appreciative of the answers received.

Paul Overell thanked Graham Fountain for his contribution to the meeting and in so doing extended an invitation to Graham to attend future meetings of the State Council.
